3. Artist must reside in Florida.
4. 2-D works must be framed appropriately with attached wire for hanging.
5. Entries must be submitted as digital files, 2-D & 3-D in jpeg format, with a viewing screen size of at least 4" x 6" .
6. Hanging pieces must not exceed 48" a side with wire attached for hanging.
7. Weight limit of 50 lbs. for all pieces.
8. Artists submitting installation work must participate in its hanging.
9. All work must be appropriately labeled.
10. Artists are encouraged to price their work for sale. A 20% donation benefiting The Elliott Museum will be deducted from all sales.
11. Artists are responsible for all shipping of artwork in reusable packaging and all transportation insurance.
12. No early withdrawals of work from show will be permitted.
12. The Elliott Museum reserves the right to use any accepted images in promotional materials.
13. The Elliott Museum reserves the right to refuse any artwork it deems inappropriate, any art framed inadequately, and/or any art misrepresented by entry image.
